

# E-registration for pharma CET in state on till April 5

**Pune:** Students aspiring for studies in the six-year integrated doctor of pharmacy (Pharm D) course will have to appear for the state government's pharmacy entrance test 'MT-CET 2015', the director of technical education (DTE) has said.

The online enrolment process for admissions to the four-year pharmacy degree (B Pharm) and Pharm D courses at government-run, aided colleges, university-managed departments and those unaided institutions, which have voluntarily agreed to be a part of the DTE-run centralized admission process, commenced on Thursday with the sale of application kits at the designated application receipt centres (ARCs).

The MT-CET, which is to be conducted in an online mode, will be held on April 25 and 26 and the results will be declared at 5pm on May 6, a notification issued by the DTE stated. The online enrolments will continue till April 5 and hall tickets for the entrance test will be distributed from April 20 onwards, the notification added.

Students who have passed or have appeared in the higher secondary certificate (Std XII, HSC) exam of the Maharashtra state education board or any equivalent board are eligible to apply for the

► For reserved category, caste and tribe validity certificates and valid non creamy layer certificates issued by competent scrutiny committees **is mandatory at the time of verification of documents at ARCs**



► NRI candidates eligible to apply for admission **against institute level seats in private unaided institutes**

such students to have studied English, physics, chemistry and either one of biology, mathematics, biotechnology or technical vocational subject for eligibility.

Also, such students must have scored a minimum 45% marks in these subjects, added together, the DTE notifica-

tion class candidates and persons with disability only from Maharashtra state, the threshold is relaxed to 40%. Candidates whose HSC or equivalent results are not declared till the last date of submission of application form, are also eligible to apply provided they meet the eligibili-
